SUBJECT: PERSONAL IRAQ: 5 MARCH: ULTIMATA

The two alternative ultimatum formulations drawn up by USUN and UKMis on 5 March follow. USUN are putting the second alternative to Powell:

## FIRST ALTERNATIVE

OP1 Calls on Iraq to take the decisions necessary in the interests of its people and the region;

OP2 Decides that unless on or before [date], the Council decides, on the basis of convincing, full, unconditional, immediate, and active cooperation by Iraq with UNMOVIC and the IAEA, that the Government of Iraq, at the highest level, is now resolved to bring to full and verified completion the disarmament process established in resolution 687(1991), Iraq will have failed to take the final opportunity afforded by resolution 1441(2002);

OP3 Decides to remain seized of the matter.

## SECOND ALTERNATIVE

OP1 Calls on Iraq to take the decisions necessary in the interests of its people and the region;

OP2 Decides that Iraq will have failed to take the final

opportunity afforded by resolution 1441(2002) unless, on or before [date], the Council concludes that Iraq has demonstrated an unconditional and irreversible strategic decision to comply immediately with its disarmament obligations under resolution 1441(2002) and previous relevant resolutions, including by yielding to UNMOVIC and IAEA possession of all weapons, weapons delivery and support systems and structures, and all information regarding prior destruction of such items, prohibited by resolution 687(1991) and all subsequent, relevant resolutions;

OP3 Decides to remain seized of the matter.
